1. OPENING OF THE SESSION .--- The House met at Half-past Eleven o'clock, a.m., pursuant to a Proclamation of His Excellency the Governor, bearing the date the twenty-eighth day of Junc, 1982.

By His Excellency Air Marshal Sir JAMES ANTHONY ROWLAND, Knight Commander of the Most Excellent Order of the British Empire, upon whom have been conferred the decorations of the Distinguished Flying Cross and the Air Force Cross, Governor of the State of New South Wales, in the Commonwealth of Australia.

"WHEREAS the Legislative Council and the Legislative Assembly of the State "of New South Wales now stand prorogued to Tuesday, the 17th day of "August, 1982, and whereas for weighty and urgent reasons it seems to me "expedient that the said Legislative Council and Legislative Assembly should "assemble for the despatch of business sooner than the said day: Now, I, Sir "JAMES ANTHONY ROWLAND, in pursuance of the power and authority in me "vested as Governor of the said State, do hereby announce and proclaim that the "said Legislative Council and Legislative Assembly shall assemble for the "despatch of business on Wednesday, the 30th day of June, 1982, at 11.30 "o'clock in the morning in the buildings known as the Legislative Council "Chambers situated in Macquarie Street, in the City of Sydney: And the "Members of the Legislative Council and the Legislative Assembly respectively "are hereby required to give their attendance at the said time and place "accordingly.

"Given under my Hand and Seal, at Sydney, this 28th day of June in "the year of Our Lord one thousand nine hundred and eighty-two, and in the "thirty-first year of Her Majesty's Reign. ~t i 2 .

- 2. ELECTORAL DISTRICT OF DRUMMOYNE:


