## Referral of the 2012-2013 Budget Estimates

- 1.1 On 15 March 2012, the Legislative Council resolved that 'the Budget Estimates and related papers for the financial year 2012-2013 presenting the amounts to be appropriated from the Consolidated Fund be referred to the General Purpose Standing Committees for inquiry and report.'
- 1.2 Each Committee was required to examine the Budget Estimates for the relevant portfolios and report to the house by the last sitting day of the first sitting week in February 2013.

## Hearings

- **1.3** The Committee held five public hearings as follows:
  - Monday 8 October 2012 Finance and Services, The Illawarra
  - Monday 8 October 2012 Planning and Infrastructure
  - Tuesday 9 October 2012 Treasury, Industrial Relations
  - Tuesday 9 October 2012 Premier, Western Sydney
  - Monday 26 November Treasury (supplementary hearing).
- 1.4 A brief summary of the key issues raised during the hearings is contained in Chapter 2.

# Chapter 2 Issues raised during hearings

This Chapter provides a brief summary by portfolio of the key issues raised during the hearings.

## Finance and Services, The Illawarra

- A hearing examining the portfolios of Finance and Services, and The Illawarra was held on Monday 8 October 2012. Issues raised during the Committee's examination of Finance and Services include:
  - Sydney Water: projected capital expenditure, water meter replacement program and estimated bills for Sydney Water customers
  - Hunter Water and future capital and infrastructure needs in the Hunter region
  - Maintenance and development of housing
  - Impact of recent amendments to workers compensation legislation.
- 2.2 Issues raised during the Committee's examination of The Illawarra include:
  - Long term lease of Port Kembla facilities
  - \$100m investment in Illawarra region, under the guidance of Infrastructure NSW
  - Public housing in Bomaderry, Warrawong, and Claymore.

# Planning and Infrastructure

- 2.3 A hearing examining the portfolios of Planning and Infrastructure was held on Monday 8 October 2012. Issues raised include:
  - Infrastructure NSW and public transport
  - Strategic Regional Land Use Policy
  - Local council involvement in development and planning
  - A New Planning System for NSW green paper
  - Development reform, especially the interaction between enterprise zones and local environment plans.

# Treasury, Industrial Relations

- A hearing examining the portfolios of Treasury and Industrial Relations was held on Tuesday 9 October 2012. Issues raised during the Committee's examination of the Treasury portfolio include:
  - Restart NSW: windfall revenues, long-term lease of the Sydney Desalination Plant, and Waratah Bonds
  - Distribution of GST revenue to NSW by the Commonwealth
  - Appointment of the Chair of Networks NSW

- Cobbora coal mine
- Electricity transactions
- Financial measures including reform of taxes and improving fiscal effectiveness across the NSW Government.

Issues raised during the Committee's examination of the Industrial Relations portfolio include:

- Negotiations with public sector employees and the Public Service Association
- Funding wage increases for community sector workers
- Work undertaken by the NSW Office of Industrial Relations
- Leave for victims of domestic violence.

# The Premier, Western Sydney

- 2.5 A hearing examining the portfolios of Premier, and Western Sydney was held on Tuesday 9 October 2012. Issues raised include:
  - The State's financial position
  - Redevelopment of Barangaroo
  - Investment in Western Sydney, including widening the M5, WestConnex, and the northwest and south-west rail projects
  - Dividends from electricity companies
  - The State's housing market and strategies to open additional land and stimulate investment
  - Shooting in national parks
  - Mr Roger Massy-Greene's appointment as Chairman of Networks NSW
  - The report into Strike Force Emblems.

# Supplementary hearing – Treasury

- 2.6 A supplementary hearing into the Treasury portfolio was held on Monday 26 November 2012. The following issues were raised:
  - NSW Auditor General's Financial Audit into the Budget Papers
  - The number, and nature, of accounting errors that resulted in a \$1 billion improvement to the Budget bottom line
  - The role played by the Auditor General in preparing state audits
  - Networks NSW, including appointments to the board and executive remuneration
  - The development of Barangaroo, especially Crown Ltd's proposal
  - The closure of the Cronulla Fisheries Centre of Excellence

  - (d) The committee comes to a conclusion as to whether the leak is of sufficient seriousness as to constitute a substantial interference with the work of the committee, the Legislative Council committee system, or the functions of the House. This occurs whether or not the source of the disclosure is discovered. (e) If the committee concludes that the leak is of sufficient seriousness, it makes a special report to the House, describing the circumstances and the investigations it has made, and recommending that the matter be referred to the Standing Committee on Parliamentary Privilege and Ethics for inquiry and report.

- (f) Following tabling of the Special Report, the House may refer the matter to the Standing Committee on Parliamentary Privilege and Ethics.
- 2) That the Chairman write to the following persons requesting an indication as to whether they were responsible for the disclosure or are able to provide any information that could be of assistance in determining the source of the disclosure:
  - Committee members including the Chairman
  - Staff of the Committee secretariat
  - Journalists who reported the disclosure.
