Terms of Reference

- 1. That the Budget Estimates and related papers for the financial year 2005-2006 presenting the amounts to be appropriated from the Consolidated Fund be referred to the General Purpose Standing Committees for inquiry and report.
- 2. That the committees consider the Budget Estimates in accordance with the allocation of portfolios to the committees.
- 3. For the purposes of this inquiry any member of the House may attend a meeting of a committee in relation to the Budget Estimates and question witnesses, participate in the deliberations of the committee at such meeting and make a dissenting statement relating to the Budget Estimates, but may not vote or be counted for the purpose of any quorum.
- 4. The committees must hear evidence on the Budget Estimates in public.
- 5. Not more than two committees are to hear evidence on the Budget Estimates simultaneously.
- 6. When a committee hears evidence on the Budget Estimates, the Chair is to call on items of expenditure in the order decided on and declare the proposed expenditure open for examination.
- 7. The committees may ask for explanations from Ministers in the House, or officers of departments, statutory bodies or corporations, relating to the items of proposed expenditure.
- 8. The report of a committee on the Budget Estimates may propose the further consideration of any items.
- 9. That a daily Hansard record of the hearings of a committee on the Budget Estimates be published as soon as practicable after each day's proceedings.
- 10. That the Leader of the Government is to provide to each Committee, by Friday 1 July 2005, a schedule outlining the attendance of relevant ministers to appear before each committee, for the committee's consideration.
- 11. A committee must not meet to hear evidence on any day on which the House sits except during any adjournment for meal breaks or after the adjournment of the House.
- 12. The committees may hold supplementary hearings as required.
- 13. The committees present a final report to the House by the last sitting day of the second sitting week in 2006—put and passed.

Chapter 1 Introduction

Referral of the 2005-2006 Budget Estimates

- 1.1 On 6 June 2005, the Legislative Council resolved that the Budget Estimates and related papers for the financial year 2005-2006 presenting the amounts to be appropriated from the Consolidated Fund be referred to the General Purpose Standing Committees (GPSCs) for inquiry and report.¹
- 1.2 Each Committee was required to examine the Budget Estimates for their relevant portfolios and report to the House by the last sitting day of the second sitting week in 2006.²

GPSC 5 Portfolio responsibilities

- 1.3 On 14 September 2005, the Legislative Council resolved that the resolution appointing five General Purpose Standing Committees be amended to reflect changes to Government Ministers' portfolio responsibilities.³
- 1.4 The following portfolio responsibilities were allocated to GPSC 5:
 - Environment
 - Arts
 - Local Government
 - Regional Development
 - Illawarra
 - Small Business
 - Natural Resources
 - Primary Industries
 - Mineral Resources
 - Ports and Waterways.

 - Friday, 16 September 2005 Regional Development, Illawarra and Small Business
 - Friday, 16 September 2005 Environment and Arts
 - Thursday, 22 September 2005 Ports and Waterways
 - Friday, 23 September 2005 Local Government
 - Friday, 9 December 2005 Natural Resources (supplementary hearing)
 - Monday, 19 December 2005 Ports and Waterways (supplementary hearing)
 - Monday, 19 December 2005 Primary Industries and Mineral Resources (supplementary hearing).

Chapter 2 Summary of issues

This chapter provides a summary by portfolio of the key issues raised as part of the General Purpose Standing Committee No 5 Inquiry into Budget Estimates 2005-2006. For further details see the Hansard record of the hearings, available on the Committee's web page at www.parliament.nsw.gov.au/gpsc5.

Natural Resources, Primary Industries and Mineral Resources

- 2.1 The Committee conducted a public hearing examining the portfolios of Natural Resources, Primary Industries and Mineral Resources on Thursday, 15 September 2005. The following issues were examined in relation to the Primary Industries portfolio:
 - the role and performance of the Advisory Council on Recreational Fishing
 - management of NSW Fisheries, including commercial buy-out of fishing licences, fish attraction devices, artificial breeding programs and marine park boundaries
 - operation of the Ovine Johne's disease levy, and the payment of compensation to affected farmers
 - the PROfarm short-course training program, designed to improve risk management by farmers
 - the use and regulation of genetically engineered canola oil.
- 2.2 The following issues were examined in relation to the Natural Resources and Mineral Resources portfolios:
 - mining inspections in NSW
 - the operation and management of the Farmers First program
 - displaced officers within the Department of Primary Industries
 - management of native vegetation in NSW, forest decline and land clearing
 - the issuing of commercial and domestic bore water licences
 - the management and operation of Forests NSW.

Supplementary hearings

- 2.3 The Committee conducted a supplementary public hearing examining the portfolio of Natural Resources on Friday, 9 December 2005. The following issues were examined:
 - water saving initiatives in NSW, including funding for the various water sharing plans in NSW
 - cross-border water management with other states under the National Water Initiative
 - changes to water pricing in NSW by the Independent Pricing and Regulatory Tribunal

- the Government's commitment to end broad scale land clearing under the *Native Vegetation Act 2003*, including compliance measures and prosecution of illegal land clearing
- measures to encourage more sustainable land management practices.
- 2.4 The Committee conducted a supplementary public hearing examining the portfolios of Primary Industries and Mineral Resources on Monday, 19 December 2005. The following issues were examined:
 - the role, Membership and performance of the Agricultural Industry Advisory Council
 - the management and operation of Forests NSW
 - the use and regulation of genetically engineered canola oil
 - locust plague management
 - the construction of coal-fired power stations in NSW
 - marine parks management and funding in NSW
 - expenditure on drought relief measures by NSW Government agencies.

Regional Development, Illawarra and Small Business

- 2.4 The Committee conducted a public hearing examining the portfolios of Regional Development, Illawarra and Small Business on Friday, 16 September 2005. The following issues were examined:
 - the major challenges facing small businesses in NSW, including petrol prices, payroll taxes and workers compensation premiums
 - the role of the Minister for the Illawarra
 - the Illawarra Escarpment Management Plan
 - the services available at the Illawarra and Bulli hospitals
 - the reduction in funding for the Department of State and Regional Development in the 2005-2006 Budget
 - port facilities in NSW, including the facilities and infrastructure available at Port Kembla, Port Botany, the Port of Newcastle and the Port of Eden
 - the allocation of funding to small businesses under the Regional Development Assistance Program.

Environment and Arts

2.5 The Committee conducted a public hearing examining the portfolios of the Environment and Arts on Friday, 16 September 2005. The following issues were examined in relation to the Environment portfolio:

- maintenance and conservation of the Manly Quarantine Station
- the purchase of Yanga Station in the Riverina
- volunteer organisations in NSW and the role of Conservation Volunteers Australia
- asbestos at the Fox Studios site in Sydney
- access to the Phillip Precinct in the Domain
- the budget allocation for the National Parks and Wildlife Service in 2005-2006
- control of feral animals and weeds in national parks.
- 2.6 The following issues were examined in relation to the Arts portfolio:
 - political donations by museums and art galleries
 - the 2005-2006 budget allocation for the Ministry for the Arts and the Australian Museum
 - funding for public library services in NSW
 - the closure of the Chauvel Cinema in Paddington
 - the hosting of the Forbes summit at the Opera House.

Ports and Waterways

- 2.7 The Committee conducted a public hearing examining the portfolio of Ports and Waterways on Thursday, 22 September 2005. The following issues were examined:
 - the creation of the Ports and Waterways portfolio, and staffing and resources for the Minister's office
 - the budget allocation for the Ports and Waterways portfolio in 2005-2006
 - the expansion of Port Botany, the transport of freight to the port by road and rail, and its environmental and social impact
 - the security of NSW ports and waterways and port charges to pay for security measures
 - the remediation of Homebush Bay and the Rhodes Peninsula
 - public access to the foreshores of Sydney Harbour
 - recent changes to boat licensing arrangements
 - employment in the various ports of NSW
 - the availability of port pilots
 - the construction and viability of the new coal loader at the Port of Newcastle
 - the closure of stevedore facilities at East Darling Harbour.

Supplementary hearing

- 2.8 The Committee conducted a supplementary public hearing examining the portfolio of Ports and Waterways on Monday, 19 December 2005. The following issues were examined:
 - the Port Botany container terminal expansion
 - the expansion of the coal loading facilities at the Port of Newcastle
 - the transfer of the car import facilities from Port Jackson to Port Kembla
 - road and rail infrastructure to the various major NSW Ports, including supporting inter-modal terminals
 - the future of Sydney Harbour as a working harbour
 - environmental issues at Port Botany
 - remedial environmental work at Homebush Bay
 - the Rose Bay and Point Piper marina moorings
 - the use of jet-skis in NSW waterways.

Local Government

- 2.9 The Committee conducted a public hearing examining the portfolio of Local Government on Friday, 23 September 2005. The following issues were examined:
 - the Regional Review Program of local councils and council mergers and forced amalgamations since 2003
 - the number and nature of state government responsibilities devolved to local councils in recent years
 - the pegging of council rates, the capacity of councils to service residents within their boundaries and additional financial assistance grants available to local councils
 - the financial watch-list of local councils, investigations into councils and the provision of strategic advice and mediation assistance to councils by the Department of Local Government in the last year
 - the skills shortage in the local government sector in NSW and means of encouraging apprentices and trainees to join local councils
 - the staffing level of the Department of Local Government and the allocation of staff between the Sydney and Nowra offices.
