Terms of Reference

- 1. That the Budget Estimates and related papers for the financial year 2005-2006 presenting the amounts to be appropriated from the Consolidated Fund be referred to the General Purpose Standing Committees for inquiry and report.
- 2. That the committees consider the Budget Estimates in accordance with the allocation of portfolios to the committees.
- 3. For the purposes of this inquiry any member of the House may attend a meeting of a committee in relation to the Budget Estimates and question witnesses, participate in the deliberations of the committee at such meeting and make a dissenting statement relating to the Budget Estimates, but may not vote or be counted for the purpose of any quorum.
- 4. The committees must hear evidence on the Budget Estimates in public.
- 5. Not more than two committees are to hear evidence on the Budget Estimates simultaneously.
- 6. When a committee hears evidence on the Budget Estimates, the Chair is to call on items of expenditure in the order decided on and declare the proposed expenditure open for examination.
- 7. The committees may ask for explanations from Ministers in the House, or officers of departments, statutory bodies or corporations, relating to the items of proposed expenditure.
- 8. The report of a committee on the Budget Estimates may propose the further consideration of any items.
- 9. That a daily Hansard record of the hearings of a committee on the Budget Estimates be published as soon as practicable after each day's proceedings.
- 10. That the Leader of the Government is to provide to each Committee, by Friday 1 July 2005, a schedule outlining the attendance of relevant ministers to appear before each committee, for the committee's consideration.
- 11. A committee must not meet to hear evidence on any day on which the House sits except during any adjournment for meal breaks or after the adjournment of the House.
- 12. The committees may hold supplementary hearings as required.
- 13. The committees present a final report to the House by the last sitting day of the second sitting week in 2006—put and passed.

Chapter 1 Introduction

Referral of the 2005-2006 Budget Estimates

- **1.1** On 6 June 2005, the Legislative Council resolved that the Budget Estimates and related papers for the financial year 2005-2006 presenting the amounts to be appropriated from the Consolidated Fund be referred to the General Purpose Standing Committees (GPSCs) for inquiry and report.²
- **1.2** Each Committee was required to examine the Budget Estimates for their relevant portfolios and report to the House by the last sitting day of the second sitting week in 2006.³

Extension to the reporting date

- **1.3** On 1 March 2006, the Legislative Council resolved that the reporting date for the GPSC 2 inquiry into the Budget Estimates and related papers for the financial year 2005-2006 be extended to Thursday, 6 April 2006.⁴
- 1.4 On 30 March 2006, the Legislative Council resolved that the reporting date for the inquiry be further extended to Thursday, 11 May 2006.⁵

GPSC 2 Portfolio responsibilities

- **1.5** On 14 September 2005, the Legislative Council resolved that the resolution appointing the five GPSCs be amended to reflect changes to Government Ministers' portfolio responsibilities.⁶
- **1.6** The following portfolio responsibilities were allocated to GPSC 2:
 - Health
 - Community Services
 - Youth
 - Ageing
 - Disability Services
 - Tourism and Sport and Recreation
 - Women

Public hearings

- **1.7** General Purpose Standing Committee No 2 examined the Budget Estimates and related papers for the financial year 2005-2006 for its portfolios at a series of public hearings held on the following dates:

 - Thursday, 22 September 2005 Ageing and Disability Services
 - Thursday, 22 September 2005 Community Services and Youth
 - Friday, 23 September 2005 Gaming and Racing, Central Coast
 - Friday, 23 September 2005 Aboriginal Affairs
 - Friday, 23 September 2005 Tourism, Sport and Recreation, Women
 - Monday, 20 February 2006 Ageing and Disability Services (supplementary hearing)
 - Tuesday, 14 March 2006 Health (supplementary hearing)
 - Wednesday, 12 April 2006 Disability Services (supplementary hearing)
- **1.8** Chapter 2 of this report provides a brief summary of some of the key issues raised during the hearings.

- **1.11** In addition, Committee Members lodged written questions on notice by placing questions on the Notice Paper on days that the House sat.

Chapter 2 Summary of issues

This chapter provides a summary by portfolio of the key issues raised as part of the General Purpose Standing Committee No 2 Inquiry into Budget Estimates 2005-2006. For further details see the Hansard record of the hearings, available on the Committee's web page at www.parliament.nsw.gov.au/gpsc2.

Health

- **2.1** The Committee conducted a public hearing examining the portfolio of Health on Tuesday, 20 September 2005. The following issues were examined:
 - access block and the incidence of patients being treated in emergency departments for an extended period without ever being admitted to other areas of the hospital
 - recruitment of nurses and midwives back to hospitals through the Nurses Reconnect program
 - the incidence of breast cancer, breast cancer mortality rates and the targeting of women of particular age groups through the Breast Screen Program
 - the restructure and merging of various Area Health Services, and the impact on staff numbers
 - the management and staffing of the Camden and Campbelltown Hospitals.

Supplementary hearing

- **2.2** The Committee conducted a supplementary hearing examining the portfolio of Health on Tuesday, 14 March 2006. The following issues were examined:
 - the delivery of services by the Greater Southern Area Health Service and the relationship of the Greater Southern Area Health Service with the Murrumbidgee Division of General Practice
 - the workers' compensation performance of NSW Health and additional cash payments to NSW Health from the Treasury Managed Fund in recognition of good performance
 - overdue accounts owed by NSW Health and the 45-day benchmark for paying creditors
 - the powers of NSW Health under the *Public Health Act 1991*, especially in relation to the operation of the M5 East Tunnel
 - the availability of community-based mental health services
 - the operation of health care agreements between NSW and other jurisdictions, notably the Australian Capital Territory

• funding provided to NSW Health by the Commonwealth Government under the Australian Health Care Agreement.

Ageing and Disability Services

- **2.3** The Committee conducted a public hearing examining the portfolios of Ageing and Disability Services on Thursday, 22 September 2005. The following issues were examined:
 - the increase in capital grants in 2005-2006 to non-profit organisations involved in ageing and disability care
 - fees for home care and attendant care services
 - funding for respite care in NSW and the number of respite beds available
 - the adoption of public-private partnerships for the provision of community and residential care services.

Supplementary hearings

- **2.4** The Committee conducted a supplementary hearing examining the portfolios of Ageing and Disability Services on Monday, 20 February 2006. The following issues were examined:
 - the provision of respite facilities for disabled youth, including by the former John Williams Respite Centre
 - the supervision of licensed and unlicensed boarding houses by the Department of Ageing, Disability and Home Care (DADHC)
 - the provision of dental care to clients of DADHC
 - the provision of accommodation support to clients of DADHC
 - issues associated with the Redfern Waterloo Development plan, including the retention of medical services in the Redfern Waterloo area
 - the adequacy of the Associations Incorporation Act 1984 in relation to the management of disability care service providers.
- **2.5** The Committee conducted a further supplementary hearing examining the portfolio of Disability Services on Wednesday, 12 April 2006. The following issues were examined:
 - progress in relocating younger people with disabilities from nursing homes to more appropriate accommodation
 - DADHC inspections of unlicensed boarding houses under the Youth and Community Services Act 1979 and action taken as a result of such inspections, with specific reference to boarding houses in Petersham
 - compliance of boarding houses with fire regulations
 - wage costs arising from the new State and Community Services Award.

Community Services and Youth

- **2.6** The Committee conducted a public hearing examining the portfolios of Community Services and Youth on Thursday, 22 September 2005. The following issues were examined:
 - the management of the Richmond Community Service Centre, including the number of child protection system caseworkers at the centre
 - the operation of the Department of Community Services' Helpline
 - the identification of new sites for community service centres
 - the regulation of the child care industry and the availability of child care places in the inner suburbs of Sydney.

Gaming and Racing, Central Coast

- **2.7** The Committee conducted a public hearing examining the portfolios of Gaming and Racing and Central Coast on Friday, 23 September 2005. The following issues were examined:
 - funding, running costs and staffing of the Office of the Minister for Gaming and Racing
 - the final cost of the Temby Inquiry into the Panthers club, including the salaries of external lawyers and consultants
 - the legal impasse between TVN and Sky Channel in relation to the broadcasting of a number of Autumn Carnival races
 - initiatives to monitor and limit activities by clubs and hotels that encourage increased gambling
 - the viability of the club industry in NSW
 - initiatives to stop promotions that result in alcohol being provided to under age persons
 - implementation of the Independent Pricing and Regulatory Tribunal report entitled *Gambling: Promoting a Culture of Responsibility*
 - public donations to the Boxing Day Tsunami relief fund
 - the provision of a range of services on the Central Coast.

Aboriginal Affairs

- **2.8** The Committee conducted a public hearing examining the portfolio of Aboriginal Affairs on Friday, 23 September 2005. The following issues were examined:
 - public comments made by the Minister for Redfern Waterloo in relation to the Redfern Waterloo Authority
 - the role of the Department of Aboriginal Affairs in relation to the Pemulwuy Project (the Aboriginal Housing group redevelopment of the Block)

- the current status of the review of the Aboriginal Land Rights Act 1983
- payments made under the Aboriginal Trust Fund Repayment scheme
- the progress of the Aboriginal Community Development Program.

Tourism, Sport and Recreation, Women

- **2.9** The Committee conducted a public hearing examining the portfolios of Tourism, Sport and Recreation, and Women on Friday, 23 September 2005. The following issues were examined in relation to the Tourism portfolio:
 - the increase in tourism to NSW from China and India
 - measures to attract more tourists to rural and regional NSW, including to the Hunter
 - tourism advertising campaigns run by the NSW Government
 - tourism in the northern rivers region and the viability of the Casino to Murwillumbah railway.
- 2.10 The following issues were examined in relation to the Sport and Recreation portfolio:
 - measures to address obesity in children
 - campaigns to encourage older people to exercise
 - the hosting of NRL State of Origin games in Sydney
 - the ongoing viability of Luna Park
 - the attraction of major sporting events to Sydney.
- **2.11** The following issues were examined in relation to the Women portfolio:
 - the representation of women's issues to the Government
 - sexual harassment in the workplace and government policies to address it
 - the operation of the new Office for Women within the Premier's Department
 - the availability of grants to fund projects run by women's groups
 - fostering respect for women in sport.
