Terms of reference

- 1. That the Budget Estimates and related papers for the financial year 2006-2007 presenting the amounts to be appropriated from the Consolidated Fund be referred to the General Purpose Standing Committees for inquiry and report.
- 2. That the committees consider the Budget Estimates in accordance with the allocation of portfolios to the committees.
- 3. For the purposes of this inquiry any member of the House may attend a meeting of a committee in relation to the Budget Estimates and question witnesses, participate in the deliberations of the committee at such meeting and make a dissenting statement relating to the Budget Estimates, but may not vote or be counted for the purpose of any quorum.
- 4. The committees must hear evidence on the Budget Estimates in public.
- 5. Not more than three committees are to hear evidence on the Budget Estimates simultaneously.
- 6. When a committee hears evidence on the Budget Estimates, the Chair is to call on items of expenditure in the order decided on and declare the proposed expenditure open for examination.
- 7. The committees may ask for explanations from Ministers in the House, or officers of departments, statutory bodies or corporations, relating to the items of proposed expenditure.
- 8. The report of a committee on the Budget Estimates may propose the further consideration of any items.
- 9. That a daily Hansard record of the hearings of a committee on the Budget Estimates be published as soon as practicable after each day's proceedings.

Referral of the 2006-2007 Budget Estimates

- **1.1** On Thursday 8 June 2006, the Legislative Council resolved 'that the Budget Estimates and related papers for the financial year 2006-2007 presenting the amounts to be appropriated from the Consolidated Fund be referred to the GPSCs for inquiry and report'.¹
- **1.2** Each committee was to examine the Budget Estimates for the relevant portfolios and report to the House by the last sitting day of November 2006.²

Hearings

Chapter 2 Issues raised during hearings

This Chapter provides a brief summary by portfolio of the key issues raised during the hearings.

Local Government

- **2.1** A hearing examining the portfolio of Local Government was held on Monday 28 August 2006. The following issues were raised:
 - cost shifting and the sustainability of local councils
 - review of the code of conduct
 - reduction in councillor numbers
 - impact of WorkChoices legislation on local government
 - issues relating to the Tweed Shire Council
 - salary and employment conditions of former employees
 - changes to council wards
 - rate pegging
 - review of rate exemptions and concessions
 - rise in petrol prices and impact on local councils
 - retained revenue and investment income
 - strategies to address gender balance in local councils.

Supplementary hearing

- **2.2** A supplementary hearing examining the portfolio of Local Government was held on Friday 10 November 2006. The following issues were raised:
 - matters relating to the site of a dis-used quarry at Hornsby, including the acquisition process undertaken by the Hornsby Council, the role of the Department of Local Government in the acquisition, and compensation payable to the site's former owner
 - matters relating to investigations into local councils undertaken by the Department of Local Government, including the resources available to the Department, the differences between inquiries, investigations and reviews, the processes involved in a review, and the trigger for an inquiry or investigation
 - investigations into the proposed construction of a cultural centre at Port Macquarie
 - monitoring the financial accountability of local councils
 - education programs to prevent dog attacks on young children
 - management plans for land deemed community land.

Western Sydney, Fair Trading

- **2.3** A hearing examining the portfolio of Western Sydney, Fair Trading was held on Monday 28 August 2006. The following issues were raised:
 - builder licences including qualifications, criminal record checks and professional development
 - complaints against builders, complaint handling system, and complaints raised by the Building Action Review Group
 - Home Building Grants Program
 - review of the Residential Tenancies Act conducted by the Office of Fair Trading and issues raised during the review, including: improving procedures for dealing with tenants in rental arrears; grounds on which tenancies are terminated; ways of handling disputes between co-tenants; and rights of boarders and lodgers
 - Fair Trading Information Centre in Parramatta
 - access to services by people of non-English speaking backgrounds
 - Office of Fair Trading working with the real estate industry to achieve better outcomes for consumers
 - community based tenancy services funded by the Office of Fair Trading
 - changes to the Fair Trading Act 1997 to more effectively deal with unfair practices and consumer scams
 - Office of Fair Trading investigators and dealing with serious misconduct
 - Rental Bond Board monies
 - number of different licenses administered/issued by Department of Fair Trading
 - Consumer Trading and Tenancy Tribunal
 - employment in Western Sydney
 - functions of the Office of Western Sydney
 - Corporate Partners For Change
 - Western Sydney Industry Awards.

Roads

- **2.4** A hearing examining the portfolio of Roads was held on Friday 1 September 2006. The following issues were raised:
 - Lane Cove Tunnel
 - repairs and compensation for damage to property
 - road maintenance

- RTA's occupational health and safety initiatives
- upgrade of the Pacific Highway
- E-tags for motor cyclists
- AusLink funding agreement
- road safety around schools
- changes to the F6
- Cross City Tunnel
- funding for the Timber Bridge Program.

Supplementary hearing

- **2.5** A supplementary hearing examining the portfolio of Roads was held on Monday 6 November 2006. The following issues were raised:
 - matters relating to the construction of the Lane Cove Tunnel, including any bonus for early completion, progress to date, expected completion date, delay of surface road works, monitoring of air quality
 - plans for the F6 transport corridor
 - roll-out of flashing lights in 100 school zones
 - changing costs of heavy vehicle registration in NSW compared to other states
 - air quality in the M5 East tunnel, including steps to improve air quality, and the potential impact of regular portal emissions
 - the Pacific Highway Upgrade program, including completion of the Possum Brush to Bundaree Creek project, and potential impacts of preferred route at Banora Point
 - roll-out of bus lane cameras in Sydney
 - funding of Timber Bridges Replacement Program
 - efforts to prevent abuse of the Mobility Parking Scheme
 - auction of rare numberplates and use of proceeds
 - update on progress in construction of the Windsor Road upgrade, and the project budget
 - any changes to the forklift and wide load regulations
 - conclusions of the report on the proposal to use an upgraded Summerland Way as an alternative to the Pacific Highway
 - RTA achievements, including receipt of two Engineering Excellence awards, and progress made in significant infrastructure projects
 - RTA's international financial reporting standards.

Planning, Redfern Waterloo, Science and Medical Research

- 2.7 A hearing examining the portfolios of Planning, Redfern Waterloo, and Science and Medical Research, was held on Friday 8 September 2006. The following issues were raised:

 - smoking in pubs and clubs
 - breast screening
 - redevelopment of 'The Block,' Redfern
 - recruitment processes for the Department of Planning
 - Metropolitan Strategy
 - Growth Centres Commission
 - approvals for coal mining
 - Major Development Monitor 2005/06
 - residential land supply
 - NSW regional planning
 - land releases in the north west growth zone.

Supplementary hearing

- **2.8** A supplementary hearing examining the portfolios of Redfern Waterloo and Planning was held on Friday 10 November 2006. The following issues were raised:

 - sale and redevelopment of Beacon Hill High School site
 - development proposals, including at Minchinbury (landfill), Callan Park, Berowra Waters Marina, and East Darling Harbour
 - turnaround times for development applications
 - Section 94 and 94A plans council inputs and appeals process
 - Cities and Centres program
 - progress of the BASIX initiative
 - new Local Environment Plan template
 - freight train expansion at Port Botany and emissions from M5 East Air Filter.

Transport

- **2.9** A hearing examining the portfolio of Housing was held on Friday 8 September 2006. The following issues were raised:
 - maintenance of ferry fleet including improvements in the Balmain Shipyard, changes in maintenance costs over last financial year and the proportion of the fleet in active service.
 - performance of Sydney Ferries Corporation including patronage levels, complaints, capacity, expenditure on charter vessels, and status of safety and reliability targets
 - Government's budgetary commitment for ferries
 - fitness testing of ferry masters and train drivers
 - distribution by CityRail of K Time Bars and newsletters to train commuters
 - new CityRail timetable including reliability of train services, safety considerations, definition of 'on time' running, patronage levels and impact of slower running times between stations

- status of infrastructure projects including upgrading of train stations, the proposed restoration of Casino Murwillumbah rail line, Rail Clearways Plan, Metropolitan Rail Expansion Plan and the North-West rail link
- rolling stock projects including maintenance and replacement of train carriages, delivery of new carriages and cleanliness and hygiene of intercity trains
- purchase of new buses including commencement schedule and cost, replacement of old buses and average age of bus fleet
- modifications to bus timetables in response to changes in demand
- introduction of T-Card ticketing system including anticipated commencement date, concession systems, impact of technical difficulties and details of contract with contractor ERG
- impact of introducing light rail into the Sydney central business district.

Supplementary hearing

- **2.10** A supplementary hearing examining the portfolio of Transport was held on Monday 6 November 2006. The following issues were raised:
 - delays in delivery of the new outer suburban OSCAR and Hunter Valley trains, including issues of budget, design and construction, and expected delivery dates
 - programs to recruit and train new drivers, including for the new OSCAR and Hunter Valley trains
 - platform safety and efforts to improve safety for parents with prams
 - issues relating to major events, including integrated ticketing, efforts to alleviate the impact of track-work, and how to improve use of public transport to major events
 - matters relating to T-Card ticketing, including project progress, timing of the trials, and contract details
 - changes to bus services, including the process for reviewing the viability of bus services as well as for introducing new services
 - improvements to bus services, including the introduction of the cashless 'Bondi Bendy' bus service
 - plans to develop a green bus dept at Leichhardt
 - efforts to improve the safety of Sydney Ferries through improved crew training, and to improve reliability through increased availability of vessels
 - measures undertaken by Sydney Ferries to counter terrorist threats.
