Yes, the Investing in Women Program will continue over the next 3 years. The 2023/24 Investing in Women Grant Round opened on 5 March 2024 and \$1 million has been allocated.

# Women's Safety Commissioner

I often meet with the Women's Safety Commissioner and other DCJ Executives who work in the Prevention of Domestic Violence and Sexual Assault Portfolio. Meetings are scheduled on a regular basis and as required.

Her role is to provide advice and support on cross-sector and whole-of-government women's safety policy development, law reform and service delivery.'

(a) Minister, what role do you have to play in each of these areas?

As the Minister for the Prevention of Domestic Violence and Sexual Assault I am responsible for the agencies working in my portfolio in these areas. As a Member of Cabinet, I am part of the policy and decision-making process that is central to government action.

Primary Prevention Strategy

I am advised:

The Domestic, Family and Sexual Violence Primary Prevention Strategy is being developed by the Department of Communities and Justice.

(21) Which stakeholder groups have been involved in the development of the primary prevention strategy for domestic violence?

I am advised:

The Domestic, Family and Sexual Violence Primary Prevention Strategy under development is informed by consultation with a range of stakeholders, including government agencies and non-government stakeholders from peak bodies and advocacy organisations, academic institutions, and organisations with expertise in diverse communities.

#### Core and Cluster

(22) Which Tranche 1 Core & Cluster programs have commenced operations as at 27th February 2024?

I am advised:

The four services contracted through Tranche 1 of the Core and Cluster Program procurement are now operational:

- Bathurst LGA – Housing Plus – staged build, partially operational

- Wagga Wagga LGA – Wagga Wagga LALC – staged build, partially operational

- Penrith LGA – Evolve Housing and Women's Community Shelters – fully operational

- Port Macquarie-Hastings – Community Housing Ltd and Liberty Domestic & Family

Violence Specialist Services (partially operational)

(23) Minister, can you guarantee that all Tranche 1 Core & Cluster accommodation will meet disability requirements?

I am advised:

All Core and Cluster refuges must meet the LAHC functional design brief requirements which includes disability modifications.

(24) Can you clarify how many additional places will be provided once the Tranche 3 of Core and Cluster is completed?

I am advised:

Once all refuges from Tranches 1, 2 and 3 are operational, more than an additional 2,900 women and children will be supported every year.

children. They are an integral initiative to support Closing the Gap Target 13, yet the NSW Government has only provided short term funding which will expire in June 2024. Will the NSW Government commit to ongoing funding for AWAN? (a) If not, why not?

I am advised:

Future funding decisions will be considered by the NSW Government as part of the process for the 2024-25 Budget.

(60) What additional steps is the NSW Government taking to address domestic and family violence in multicultural communities, particularly in relation to;

(a) Funding?

(b) Building a workforce of multicultural specialist workers?

- (c) Codesigned and community led primary prevention and early intervention?
- (d) Access to income support, health care and housing for people on temporary visas?

#### I am advised:

The NSW Domestic and Family Violence Plan 2022-2027 and NSW Sexual Violence Plan 2022-2027 commit the NSW Government to activity that supports multicultural communities that experience domestic, family and sexual violence. This includes activity centred on early intervention.

The Department of Communities of Justice is developing a 10-year NSW DFV Workforce Development Strategy which will seek to enhance the capability and competency of the domestic and family violence workforce, including multicultural specialist workers Future funding decisions will be considered by the NSW Government as part of the process for the 2024-25 Budget.

(61) Will the NSW Government commit to establishing a Domestic and Family Violence Multicultural Committee as part of the NSW Domestic and Family Violence and Sexual Assault Council to inform whole-of-government strategies at the intersections of multiculturalism and domestic and family violence?

I am advised:

The Office of the Women's Safety Commissioner is currently leading a review of domestic, family, and sexual violence (DFSV) Governance in NSW. This will include consideration of any required changes to the DFSV Governance Framework in NSW.

(62) Following the closure of tenders for Tranche 3 of Core and Cluster, is it expected that the NSW Government will meet its original Core and Cluster target of a total of 75 refuges (currently 39 approved for progression), with funding prioritised for a total of 21 Aboriginal-led refuges and for areas of high unmet need and access demand?(a) If not, why not?

I am advised:

The rollout of Tranche 3 of Core and Cluster is currently in progress. Once all refuges are operational (through Tranches 1, 2 and 3), it is expected that more than an additional 2,900 women and children will be supported each year.
