## COUNCIL REPLACED BY A LEGISLATIVE COUNCIL AND A LEGISLATIVE ASSEMBLY

In 1855, the Sixth Council, under the powers conferred by clause XXXII of the Imperial Act, 13 and 14 Vic. cap. 59 (August, 1850) passed a bill "to confer a Constitution on New South Wales and to grant a Civil List to Her Majesty". The bill provided inter alia that "There shall be in place of the Legislative Council now subsisting One Legislative Council and One Legislative Assembly . . .". Assent was reserved, and the Bill was taken to England, where the Imperial Parliament, after inserting some amendments, passed the Act 18 and 19 Vic. cap. 54 (the New South Wales Act, as amended, being annexed thereto) which enabled Her Majesty to assent to the New South Wales Bill. Royal Assent was given on 16 July, 1855, the Act proclaimed on 24 November following, and the first Parliament opened on 22 May, 1856.

The maximum period between general elections for the Legislative Assembly extended from three to four years following referendum and Royal Assent of the Constitution (Legislative Assembly) Amendment Act, No. 102, 1981 (Parliament no. 51).
